

RESOLUTION NO. 28

AUTHORIZING AGREEMENTS REGARDING THE CHILDREN'S ADVOCACY CENTER AND AMENDING THE 2014 CHILDREN, YOUTH AND FAMILIES BUDGET

By Social Services Committee and Mr. Clenahan:

WHEREAS, The Commissioner of the Department for Children, Youth and Families has requested authorization to enter into an agreement with the NYS Office of Children and Family Services regarding the Children's Advocacy Center for the period commencing February 1, 2014 and ending January 31, 2015 in the amount of \$151,231, and

WHEREAS, The Commissioner has also requested authorization to renew an interdepartmental agreement with the Albany County Crime Victims and Violence Center for the same term indicated above in the amount of \$38,500 regarding the investigation and prosecution of child abuse cases, and

WHEREAS, The Commissioner indicated that the funding will be used to offset the salary and fringe benefits for clerical support at the Children's Advocacy Center and for a Family Advocate position at the County Crime Victims and Sexual Violence Center, and

WHEREAS, The Commissioner also requested a budget amendment in order to incorporate \$73,179 of the aforementioned funding into the 2014 Department for Children, Youth and Families Budget, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter an agreement with the NYS Office of Children and Family Services regarding the aforementioned grant award in the amount of \$151,231 for the period February 1, 2014 through January 31, 2015, and, be it further

RESOLVED, That the County Executive is also authorized to execute an interdepartmental agreement between the Department for Children, Youth and Families and the Albany County Crime Victims and Violence Center in the amount of \$38,500 for the period February 1, 2014 through January 31, 2015, and, be it further

RESOLVED, That the 2014 Department for Children, Youth and Families Budget is amended as follows:

Increase Revenue Account A3407 Child Advocacy Center by \$73,179

Increase Appropriation Account A6119.2 by \$500 by increasing Line Item A6119 2 2001 Office Equipment by \$500

Increase Appropriation Account A6119.4 by \$72,679 by increasing the following Line Items:

A6119 4 4020 Office Supplies by \$4,000

A6119 4 4036 Telephone \$800

A6119 4 4037 Insurance \$1,717

A6119 4 4039 Conferences, Training, Tuition \$336

A6119 4 4040 Books/Transcripts/Subscripts \$750

A6119 4 4042 Printing and Advertising \$5,531

A6119 4 4046 Fees For Services by \$59,545

RESOLVED, That the Albany County Attorney is authorized to approve said agreements as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
