

RESOLUTION NO. 16

AUTHORIZING AGREEMENTS REGARDING THE CHILDREN'S ADVOCACY CENTER AND AMENDING THE 2013 CHILDREN, YOUTH AND FAMILIES BUDGET

By Social Services Committee:

WHEREAS, The Commissioner of the Department for Children, Youth and Families has requested authorization to enter into an agreement with the NYS Office of Children and Family Services regarding the acceptance of grant funding for the Child Advocacy Center in the amount of \$151,195 commencing February 1, 2013 and ending January 31, 2014, and

WHEREAS, The Child Advocacy Center grant funding will allow for a coordinated approach for the investigation and prosecution of child abuse cases within the Department for Children, Youth and Families, the Albany County District Attorney's Office, the Crime Victim and Sexual Violence Center and County law enforcement agencies, and

WHEREAS, The Commissioner also requested authorization to enter into an agreement with the Crime Victim's and Sexual Violence Center and indicated that \$36,000 of the grant will be used to offset Crime Victim's and Sexual Violence Center staff, training for staff, costs for office supplies, as well as to support a collaborative community education and outreach campaign, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into agreements with the NYS Office of Children, Youth and Family Services regarding the Child Advocacy Center in the amount of \$151,195, and the Crime Victim's and Sexual Violence Center in the amount of \$36,000 commencing February 1, 2013 and ending January 31, 2014, and, be it further

RESOLVED, That the 2013 Department for Children, Youth and Families Budget is amended to incorporate a portion of the aforementioned funding as follows:

Increase Revenue Account A3407 Child Advocacy Center by \$72,795

Increase Appropriation Account A6119.2 by \$800 by increasing the following line item A6119 2 2001 Office Equipment by \$800

Increase Appropriation Account A6119.4 by \$71,995 by increasing the following line items:

Increase Line Item A6119 4 4020 Office Supplies \$3,500

Increase Line Item A6119 4 4036 Telephone by \$800
Increase Line Item A6119 4 4040 Books/Transcripts/Subscripts by \$750
Increase Line Item A6119 4 4042 Printing and Advertising by \$5,000
Increase Line Item A6119 4 4046 Fees for Services by \$46,945
Increase Line Item A6119 4 4093 Conferences, Training, Tuition \$15,000

and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
